# Your planned visit; more or less than one year?

## More than one year; Moving to Sweden

- ▶ Listed in the Swedish Population Register and assigned a Swedish personal identity number
- ▶ Everyone listed in the Swedish Population Register will also be tax-registered.

## Less than one year; Coordination number

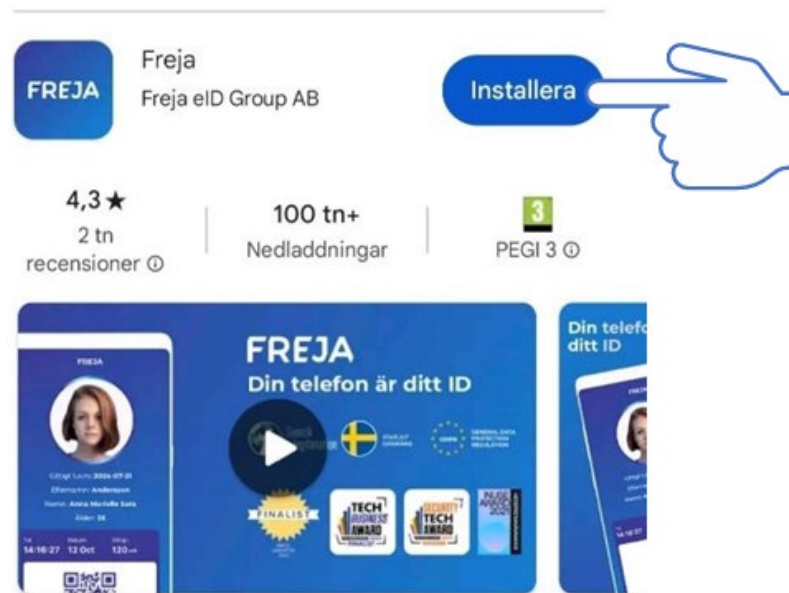
- ▶ Unique identifier at Swedish Tax Agency
- ▶ Have a connection to Sweden and able to show that you need a coordination number.
- ▶ And/or if you are going to work in Sweden, you need to register for tax.

# Moving to Sweden

- ▶ If you plan to stay longer than one year, you and your family need to be listed in the Swedish population register.
- ▶ You need to hand in one notification per person moving with you to Sweden
- ▶ The notification is preferable done online using Freja ID, Foreign eID or Swedish Bank-id
- ▶ Once the notifications have been submitted and registered, you need to make an appointment at "Statens Servicecenter" for identity check
- ▶ If you are not able to do the notification online, it can be done without logging in. In this case, each of submitted notifications need to be printed and brought along with you at the booked appointment with us at "Statens Servicecenter"

# Download Freja e-ID

Step 1. Google play or App Store:

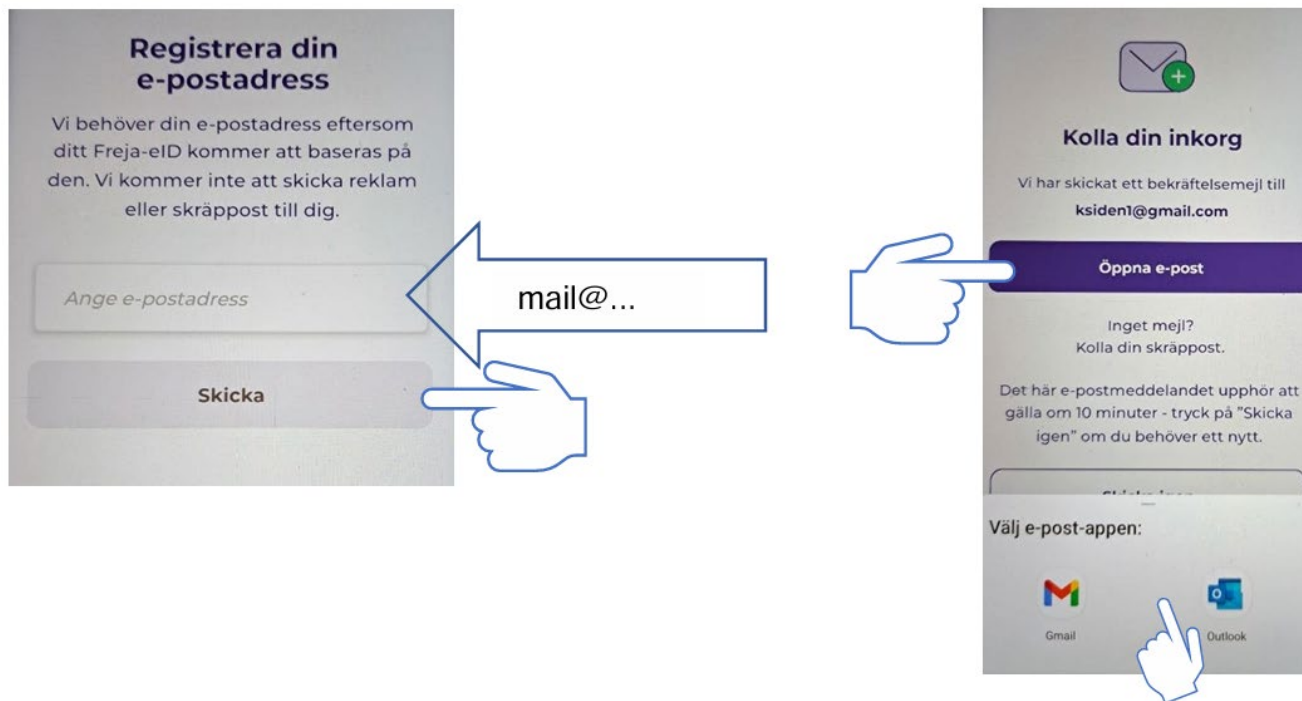

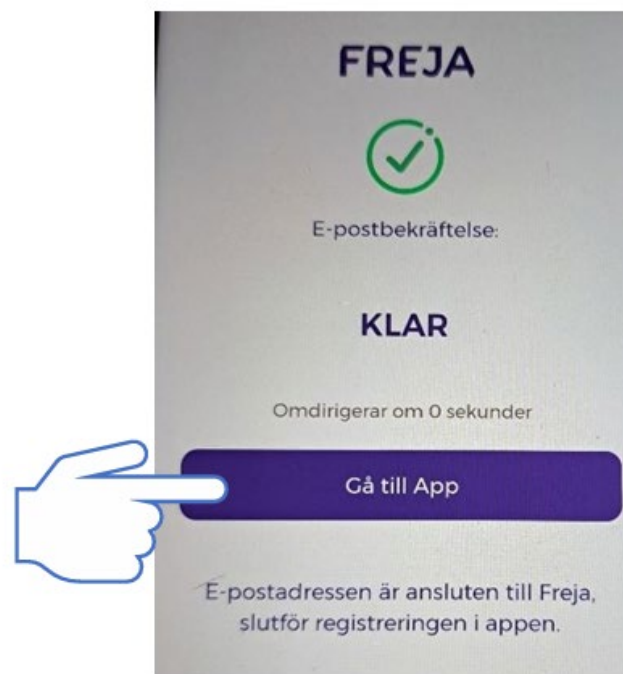
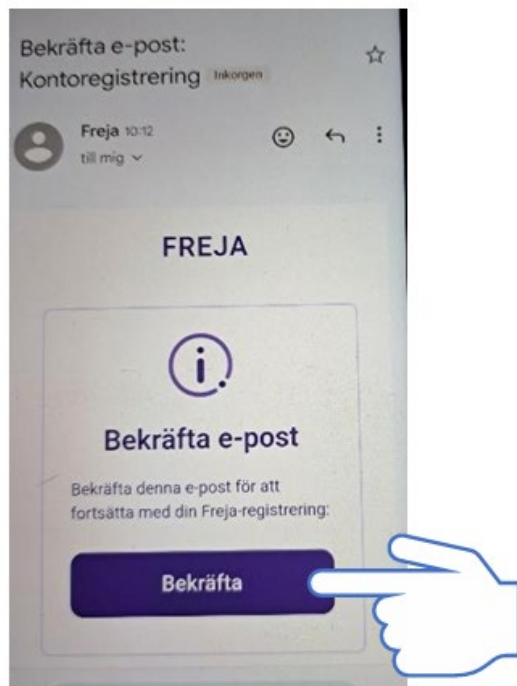

Step 4. Enter your email address and select “Skicka” (Send). Open your email in the app you are using.



Step 5. Go to your email app. Open the email from Freja and select "Bekräfta" (Confirm). Then click "Gå till app" (Go to app).





Step 6. Choose a pin code. If you want, you can add fingerprints. Select “Ok”.

Step 7. When the blue page appears, you can exit. **Close Freja completely.**

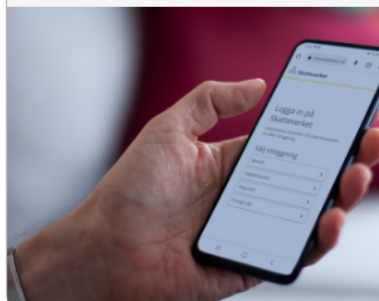

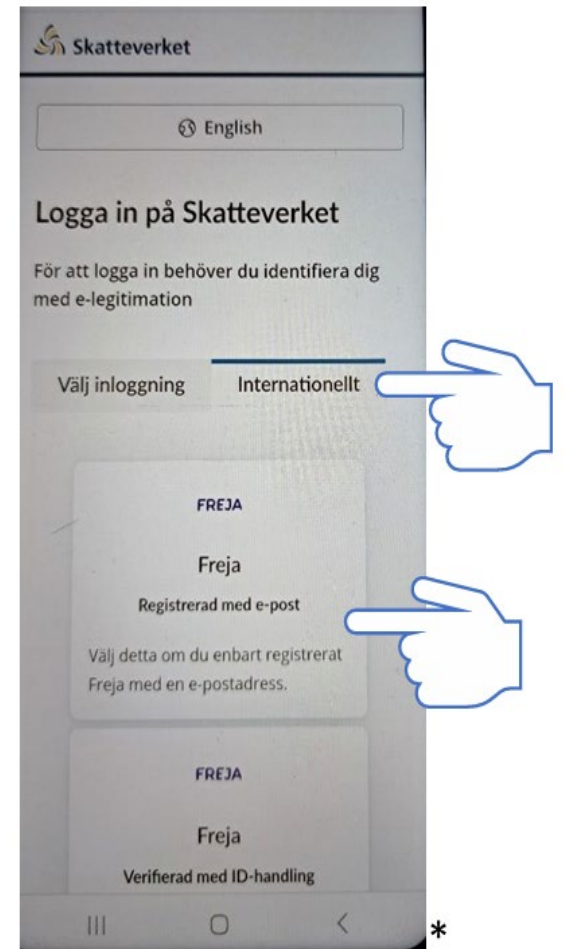

## Log in to Skatteverket using your phone and Freja App

Step 1. Select "Internationellt". Continue with "Freja, registrerad med e-post" (Freja, registered with email)

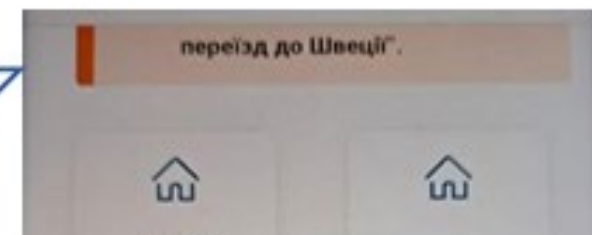
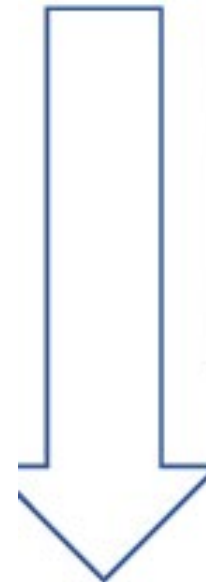
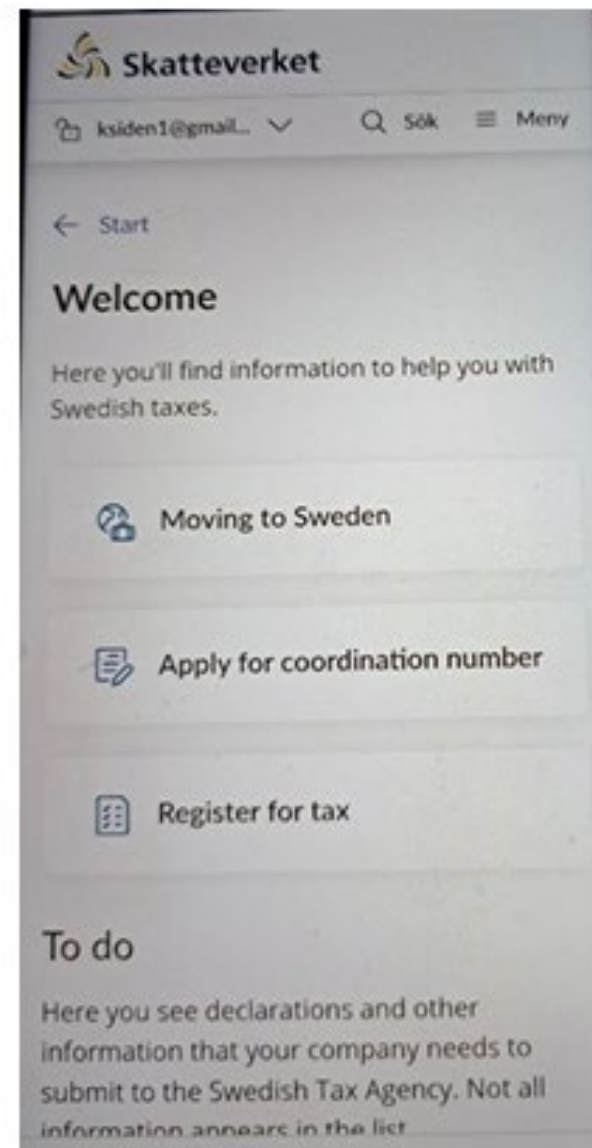
Step 2. Freja opens. Select "Godkänn" (Approve) and enter your PIN.

Please note! You will be required to upload (or taking pictures of) requested documents depending on your status (Passports, Residence permit card, Certificates of marriage or birth of children, Course admission and registration etc...)





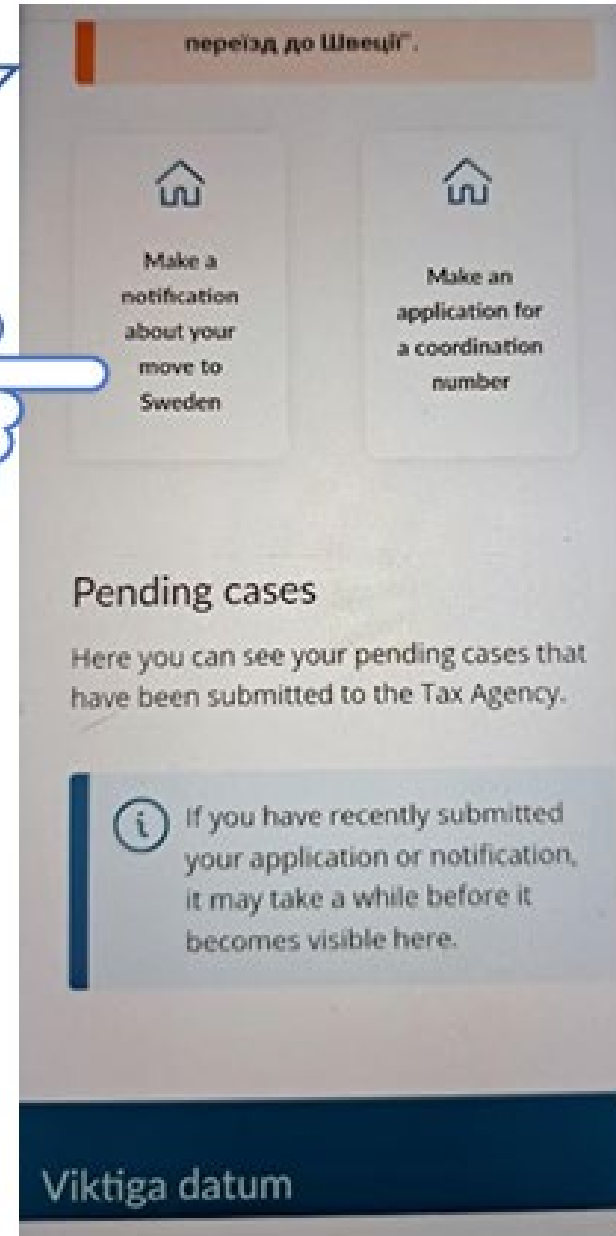
Step 3. When you enter the Swedish Tax Agency, scroll down.



Step 4. Select from the houses "Flytta till Sverige" (Move to Sweden) or "Samordningsnummer" (Coordination number).

You will see the ongoing case at the bottom (if you are going to add documents, for example).

5. Follow the instruction given for the notification of your move to Sweden. Once done, review and submit your application. Please make sure that you have been given confirmation of notification completed


6. Please note that notifications (one for each person) performed without login need to be printed and brought along with you to your booked identity check appointment

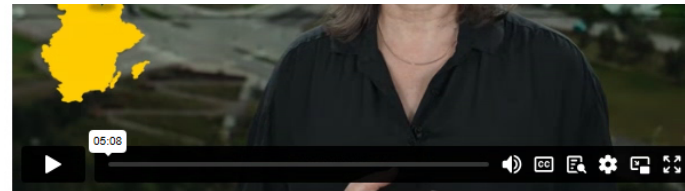

### Book an appointment for an identity check

You and your family members who are moving with you must visit a Swedish state service centre in person for an identity check when you have arrived in Sweden.

You have to book an appointment for an identity check at selected service centres. You can also submit your notification if you did not submit it directly in the e-service.

#### Citizen of an EU/EEA country

You can work, study or support yourself with your own assets in Sweden.

## Social insurance in Sweden

- ▶ When you register you and your family in Sweden, you might have the right to take part of Swedish social insurances
- ▶ Social insurance is based on two identities:
  - ▶ 1. For being an inhabitant in Sweden
  - ▶ 2. As an employee (or sole trader) working and paying tax in Sweden
- ▶ Your eligibility for social insurance will be tested once you have a need for social insurance.
- ▶ For those who know they are in need (or have the right to) benefits, please notify "Försäkringskassan" by filling the form "5456en Information when moving to or working in Sweden"
